For the TBTA Subordinate Revenue Variable Rate Refunding Bonds, Series 2000AB:

The former \$181,300,000 TBTA Subordinate Revenue Variable Rate Refunding Bonds, Series 2000A (CUSIP No. 896033QR1) and \$72,500,000 TBTA Subordinate Revenue Variable Rate Refunding Bonds, Series 2000B (CUSIP No. 896033QS9) were consolidated into one new \$201,120,000 TBTA Subordinate Revenue Variable Rate Refunding Bonds, Series 2000AB (CUSIP No. 89602NJY1) on June 20, 2007. The liquidity facility securing the Series 2000B Bonds with Landesbank Baden-Württemberg was terminated on June 20, 2007. The liquidity facility securing the Series 2000A Bonds with JPMorgan Chase was extended and consolidated with the liquidity facility securing the new Series 2000AB Bonds. The new TBTA Subordinate Revenue Variable Rate Refunding Bonds, Series 2000AB are secured by a Standby Bond Purchase Agreement with JPMorgan Chase Bank N.A. that expires on October 7, 2014. All other terms and conditions remain unchanged.
